## 2 Future Prospect

(1) Under the supervision of the Tokyo District Court and Mr. Hirohisa Kagami, Attorneyat-Law, who was appointed by the Tokyo District Court as the Supervisor, UHD will devote all its effort to revitalize its business with the support from Nippon Sangyo Suishin Kiko Group with whom UHD has entered into Memorandum of Understanding regarding the

sponsor support.

(2) UHD issued bonds through the book-entry transfer system of Japan Securities Depository

Center, Inc("JASDEC"). Since UHD are unable to immediately and accurately identify

current bondholders, UHD will continue to request information from JASDEC and the

account management institution, and also ask bondholders to provide with information in the

future.

for the court and UHD to contact bondholders regarding the submission of proofs of claims

and other matters in the course of carrying out the civil rehabilitation proceedings. Please
